## Pre-Purchase Examination Donald Savage, DVM

This examination is being performed by the examiner for the prospective buyer. This is not a pass/fail situation. The horse's information, clinical examination, and laboratory results on this date will be evaluated by the examiner. After the exam, a list of normal or abnormal conditions the examiner feels are present and significant will be presented to the prospective buyer or their agent. After this information is presented it is the responsibility of the buyer to decide on the suitability of the animal for their needs.

Many subtle internal medical or musculoskeletal problems are difficult to diagnose or will go unrecognized on a routine prepurchase examination. Recurrent colics, "tying-up", low grade bronchitis, exercise induced pulmonary hemorrhage, pregnancy, impaired vision, recurrent uveitis, non-sweating, subclinical Cushing's disease, subclinical Lyme's disease, subclinical EPM, and subtle lameness are some of the occasional conditions missed on these examinations. If the buyer has ridden this horse in the occupation and at the intensity it is being purchased for, many of the above conditions could be recognized or ruled out.
